## **CHANGE OF NAME OF SPH REIT AND THE MANAGER**

SPH REIT Management Pte. Ltd., in its capacity as the manager of SPH REIT (the “**Trust**” and in its capacity as the manager of the Trust, the “**Manager**”), wishes to announce the following changes to the names and other particulars of the entities and securities referred to below.

### **1. Change of Name of the Trust**

With the approval of DBS Trustee Limited, in its capacity as trustee of the Trust (the “**Trustee**”), the name of the Trust will be changed from “SPH REIT” to “PARAGON REIT” with effect from 3 January 2023.

In connection with the above, the trust deed dated 9 July 2013 constituting the Trust (as amended) shall, pursuant to a supplemental deed to be entered into between the Trustee and the Manager, be amended to reflect the change of name of the Trust.

### **2. Change of Security and Counter Names of the Trust**
